## Representative Cases

- Obtained outright dismissal of lawsuit claiming, among other things, discrimination and harassment against group of five independent directors of privately-held company.
- Represented receiver for a company used to perpetrate a Ponzi scheme on investors and successfully prosecuted claim against Deutsche Bank to invalidate its security interest on securities deposited in the name of the company, resulting in recovery of more than \$20 million for the estate and defrauded investors. (Second Circuit, 386 F.3d 438; District Court, 279 F.Supp. 2d 247).

- Obtained outright dismissal of lawsuit seeking over \$80 million from real estate developer following more than a decade of litigation and multiple appeals. (New York Appellate Division, 155 A.D.3d 405).
